## Twentieth Biennial Congress to be held in Tübingen, Germany, July 28-31, 2015

The International Society for the History of Rhetoric (ISHR) will celebrate its Twentieth Biennial Conference, July 28-31, 2015, at the Universität Tübingen in Germany, the home institution of our current President, Manfred Kraus. The Universität Tübingen is one of Europe's oldest universities, founded in 1477 by Count Eberhard "the Bearded" of Württemberg.

Tübingen notables include Phillip Melancthon (who taught there from 1514-1518), Hegel, Hölderlin and Schelling, Mörike and Uhland, Johannes Kepler and Wilhelm Schickard. Tübingen will be the smallest conference city in which ISHR has ever met with a population of about 50,000 (including students).

The dates are a little later than usual since summer classes at Tübingen do not end until Friday, July 24th. The Welcoming Reception is planned for Monday evening, July 27th, followed by four conference days, with the banquet on Friday evening and excursions on Saturday, Aug 1st. Concurrent sessions will be held in the Modern Languages building, **Brechtbau**, which houses the Department of Rhetoric:

### **Carl Joachim Classen**

It is with sadness and deep respect that we announce the passing of Professor Carl Joachim Classen, professor of Greek at the University of Göttingen and past president of ISHR from 1987 to 1989, on September 29,

2013. He was born in

Prof. Classen defended his doctorate at the University of Hamburg, and, throughout his illustrious career, led studies at Oxford, lectured in classical philology in Nigeria, and worked in Tübingen, Berlin, and Würzburg. In 1973 he became a professor at the University of Göttingen, and became emeritus in 1993. He received his D.Litt. while serving as a visiting professor at Oxford. During his career, he served as a visiting professor in Austin, TX; Changchun, China; Rome, Italy; Princeton NJ; and Tartu, Estonia. In 2000, Prof. Classen received an honorary doctorate from the University of Tartu, Estonia, for his work with foreign student exchange.

In addition to serving ISHR since its inception in 1977 and as the Society's sixth President, Prof. Classen was a member of the Göttingen Academy of Sciences and chairman of several scientific societies.

We will always remember Professor Classen as an esteemed scholar of classical philology, Greek and Roman rhetoric, humanism, and the heritage of antiquity.

### **Lilia Metodieva–Rojdestvenska**

A head of the Master's program in Rhetoric of Sofia University, a former head of the Rhetoric Department, a member of the Union of Scientists, the Union of Bulgarian Journalists and the International Organization of Journalists, a member of the International Society for the History of Rhetoric and its Council, and a member of the editorial board of *Rhetorica*, Associate Prof. Lilia Metodieva passed away unexpectedly on February 13, 2012.

Prof. Lilia Metodieva gave nearly twenty years of her life to study parliamentary rhetoric. As a head of the project "Civil Control of Parliamentarism" and many other projects on parliamentary debate Dr. L. Metodieva worked skillfully with great passion and enthusiasm to improve the democratic character of Bulgarian parliamentarism. As a tutor she taught courses in Political Rhetoric, Public Speaking, and the History of Bulgarian Rhetoric.

Prof. Lilia Metodieva participated actively in many national and international conferences in rhetoric, sometimes as a member of the organizing committees.

She was a tutor of many doctoral students. As the author of many monographs on Parliamentary Rhetoric and the History of Bulgarian Rhetoric, she compiled and edited the book *New Research on the History of Rhetoric* last year. The work covers outstanding scholars in the field of Rhetoric from many countries.

Prof. Lilia Metodieva dedicated her life to protecting and defending civic life on many significant questions in Bulgarian society.

With the death of Dr. Lilia Metodieva – the Department of "Rhetoric," the Faculty of Philosophy and the Sofia University "St. Kliment Ohridski " lost one of its brilliant representatives of Rhetoric,

and the students – one of their favorite teachers and the International Society for the History of Rhetoric lost a significant scholar.

## Marijke Spies



Prof. Marijke Spies, ISHR President from 1997-99, passed away 12 May 2013 in Amsterdam. Born in Eindhoven in 1934, Prof. Spies devoted her life to the study of pre-1770 Dutch literature and Renaissance *photo:*

*Roeland Fossen* Rhetoric and Poetics. She was an emeritus professor at the University of Amsterdam.

During her many years at the University of Amsterdam, from 1962 to 1997, Prof. Spies produced pioneering studies on Vondel, Roemer Visscher, and many other authors and rhetoricians of the sixteenth and seventeenth centuries. She will always be remembered as a dedicated leader and a generous professor who inspired in her students the love of old Dutch texts.

## New Contract Negotiated for *Rhetorica*

A special sub-committee of ISHR's Membership Committee took charge of reviewing our contract with the University of California Press when it came up for renewal. After meticulously reviewing bids from three different publishers (from Routledge, Taylor & Francis, Philadelphia/London; Brill, Leiden; along with a revised bid from the University of California Press, Berkeley), the committee negotiated an amendment to our former Memorandum of Agreement with UC Press. The ISHR Council endorsed the committee's recommendation and President Martin Camargo officially signed that amendment a few days prior to the deadline July 1, 2012, and, under our new President, Manfred Kraus, the amendment was converted to a new MOA on July 31, 2013.

The new Memorandum of Agreement has changed the former MOA in several important ways, including:

- ISHR will be responsible for management of individual subscriptions (membership), including pricing decisions; the Publisher will be responsible for institutional subscription and their pricing only.
- All revenues from individual subscriptions will go directly to the ISHR Treasurer as membership dues.
- The Publisher will pay an annual royalty of 40% on revenues from institutional subscriptions.
- There will be no Press Fee.

By giving ISHR control over individual membership lists, the Amendment promises to provide better service to the membership.

**ENGLISH:****CALL FOR PAPERS**

The Twentieth Biennial Conference of the International Society for the History of Rhetoric (ISHR) will be held in Tübingen, Germany, from Tuesday, July 28 to Friday, July 31, 2015. The Biennial Conference of ISHR brings together several hundred specialists in the history of rhetoric from around thirty countries.

**SCHOLARLY FOCUS OF THE CONFERENCE**

The Society calls for papers that focus on the historical aspect of the theory and practice of rhetoric. The special theme of the conference will be "**Rhetoric across Cultures.**" Papers dedicated to this theme are invited to interpret the concept of cultures in its broadest sense and to explore not only the role of rhetoric in relationships between diverse coexisting (national, social, intellectual) cultures, but also in diachronic relationships between earlier and later (ancient, medieval, modern) cultures, or else 'supracultural' anthropological concepts of rhetoric, the contribution of rhetoric to human culture as such, or other related topics.

Papers are also invited on every aspect of the history of rhetoric in all periods and languages and the relationship of rhetoric to poetics, literary theory and criticism, philosophy, politics, art, religion, geographic areas and other elements of the cultural context.

**PROCEDURE FOR SUBMISSION**

Proposals should be submitted for a 20-minute presentation delivered in English, French, German, Italian, Latin, or Spanish. Group proposals are welcome, under the following conditions. The group must consist of 3 or 4 speakers (or any aggregate of these numbers) dealing with a common theme in order to form a coherent panel. The person responsible for the panel, who may also be one of the speakers, has the task of introducing the papers and guiding the discussion. Each speaker in a panel should submit a proposal form for his or her own paper and send the finished paper to the head of the panel before the conference; proposals for such papers must specify the panel for which they are intended. In addition, the person who is responsible for the panel must complete and submit a separate form explaining the purpose of the proposed panel.

**DEADLINE FOR PROPOSALS**

**The deadline for submitting proposals is May 4, 2014.**

Notifications of acceptance will be sent out before the end of August 2014. In a few cases participants may require an earlier acceptance date in order to secure funding. We will try to accommodate such requests if they are made with appropriate documentation.

Information about the Conference, including accommodation at favorable rates, will be provided during the academic year 2014-2015. The conference registration fee is still to be determined. Graduate students and scholars from underrepresented countries pay reduced registration fees and may be eligible for travel grants.

**GUIDELINES FOR THE PREPARATION OF PROPOSALS:**

The members of ISHR come from many countries and academic disciplines. The following guidelines are intended to make it easier for us to come together and understand one another's proposals. The Program Committee recommends that all proposals contain:

1) a definition – accessible to a non-specialist – of the field of the proposal, including chronological period, language, texts, and other sources;

- 2) a statement of the problem that will be treated; its place in relation to the present state of research in the field under consideration; its significance for the history of rhetoric;
- 3) a summary of the stages of argumentation involved in treating the problem;
- 4) scientific results and advances.

## FRANÇAIS:

### APPEL À COMMUNICATIONS

Le vingtième Congrès de la Société Internationale d'Histoire de la Rhétorique (ISHR) se tiendra à Tübingen, Allemagne, du mardi 28 juillet au vendredi 31 juillet 2015. Les Congrès bisannuels de l'ISHR rassemblent plusieurs centaines de spécialistes de l'histoire de la rhétorique, venant d'une trentaine de pays.

### THÈME SCIENTIFIQUE DU CONGRÈS

La Société lance un appel à communications sur la théorie et la pratique de la rhétorique dans les différents contextes historiques. Le thème principal du Congrès sera « **La rhétorique à travers les cultures** ». Les communications consacrées à ce thème pourront interpréter la notion de cultures dans son sens le plus large et examiner non seulement le rôle de la rhétorique dans les relations entre diverses cultures (nationales, sociales, intellectuelles) coexistantes, mais aussi dans les relations diachroniques entre cultures antérieures et postérieures (anciennes, médiévales, modernes), ou bien les conceptions anthropologiques et 'supra-culturelles' de la rhétorique, ou encore les contributions de la rhétorique à la culture humaine en général, ou autres sujets connexes.

Sont également bienvenues les communications hors thème, portant sur tous les aspects de l'histoire de la rhétorique, à toutes les époques et dans toutes les langues, et sur les relations de la rhétorique avec la poétique, la théorie et la critique littéraires, la philosophie, la politique, l'art, la religion, les aires géographiques et tous les autres éléments du contexte culturel.

### COMMENT SOUMETTRE VOTRE PROPOSITION DE COMMUNICATION ?

Les communications sont d'une durée de vingt minutes et peuvent être présentées en allemand, en anglais, en espagnol, en français, en italien ou en latin. Les propositions peuvent aussi émaner d'un groupe pour une session commune. Dans ce cas, elles seront acceptées aux conditions suivantes : le groupe

doit être formé de trois ou quatre orateurs (ou un multiple quelconque de ces nombres) traitant un thème commun, de manière à former une séance cohérente. La personne responsable de la session, qui pourra aussi être un des orateurs, a la tâche d'introduire les exposés et de guider la discussion. Chaque orateur doit remplir un formulaire de proposition pour sa propre communication et s'engager à communiquer cette dernière au responsable de la session avant le Congrès ; les propositions entrant dans cette catégorie doivent préciser à quel groupe elles se rattachent. En outre, le responsable du groupe remplit et soumet un formulaire expliquant l'objet de la session proposée.

Les membres de l'ISHR viennent de différents pays et de différentes disciplines universitaires. Les conseils ci-dessous sont destinés à nous rapprocher les uns des autres et à faciliter la compréhension et l'évaluation des propositions soumises par chacun. C'est pourquoi le Comité de programme recommande que toutes les propositions comportent :

#### AUFRUF ZUR EINSENDUNG VON VORTRAGSTHEMEN

Der Zwanzigste Kongreß der Internationalen Gesellschaft für Geschichte der Rhetorik (ISHR) findet von Dienstag, dem 28. Juli bis Freitag, den 31. Juli 2015 in Tübingen statt. Der in zweijährlichem Turnus stattfindende Kongreß der ISHR versammelt mehrere hundert Spezialisten auf dem Gebiete der Geschichte der Rhetorik aus etwa dreißig Ländern.

#### WISSENSCHAFTLICHER SCHWERPUNKT DER TAGUNG

Die ISHR fordert auf zur Einsendung von Vortragsthemen mit Bezug auf Theorie und Praxis der Rhetorik in ihrer geschichtlichen Dimension. Das Schwerpunktthema der Tagung lautet **“Rhetorik transkulturell”**. Diesem Thema gewidmete Beiträge dürfen und sollen “Kultur” im weitesten Sinne verstehen und die Rolle der Rhetorik nicht nur in den Beziehungen zwischen verschiedenen koexistenten (nationalen, sozialen, intellektuellen) Kulturen, sondern auch diachron in Beziehungen zwischen früheren und späteren (antiken, mittelalterlichen, neuzeitlichen, modernen) Kulturen oder auch ‘suprakulturelle’ anthropologisch orientierte Konzeptionen von Rhetorik, den Beitrag der Rhetorik

zur Grundlegung menschlicher Kultur oder andere verwandte Themen untersuchen.

Willkommen sind aber auch Vorträge über beliebige Aspekte der Geschichte der Rhetorik aller Epochen und Sprachen und die Beziehungen der Rhetorik zu Poetik, Literaturtheorie und Literaturwissenschaft, Philosophie, Politik, Kunst, Religion, geographischen Räumen und anderen Bereichen des kulturellen Lebens.

#### EINREICHUNGSVERFAHREN

Eingereicht werden können Vorschläge für Vorträge von jeweils 20 Minuten Länge in den Sprachen Deutsch, Englisch, Französisch, Italienisch, Latein oder Spanisch. Vorschläge für Vortragsgruppen sind unter folgenden Bedingungen möglich: Die Gruppe muß aus drei oder vier Vortragenden (oder einem Vielfachen dieser Zahlen) bestehen, die sich mit einem übergreifenden Rahmenthema beschäftigen und so ein inhaltlich zusammenhängendes Diskussionsforum (Panel) bilden. Die für das ganze Panel verantwortlich zeichnende Person, die auch selbst eine(r) der Vortragenden sein kann, hat die Aufgabe, in die Beiträge einzuführen und die Diskussion zu moderieren. Jeder/jede Vortragende muß ein eigenes Formblatt für seinen/ihren eigenen Vortrag einreichen und den fertigen Vortrag vor der Tagung dem Moderator des Forums zuschicken; auf dem Formblatt ist unbedingt die Gruppe anzugeben, welcher der jeweilige Vortrag zuzuordnen ist. - 3) eine Skizze der wesentlichen Argumentationsschritte;
- 4) die erzielten wissenschaftlichen Ergebnisse und Fortschritte.
